CONTRACT TERMS

- Contract gas is delivered on the driver's regular route on a "KEEP FULL" basis. Delivery cannot be held back to a later date and there are no special deliveries. The route provides service approximately every 30 days, or more often if needed by the customer.
- All gas delivered between **OCTOBER 1, 2022 and APRIL 01, 2023** to contracted customers is "Contract Gas." Gas purchased after April 01, 2023 will be at the current cash price. Any credit remaining from your deposit or prepay will be applied to your account at the end of the contract season.

Deliveries made between Oct and April will be @ contract price unless you have used all of your contract gas. If the market price of LP falls lower than the contract price, you are obligated to take delivery @ the contract price.
